The purpose of this session is to give due consideration to the seven resolutions introduced during the DPCA General Meeting earlier this year. This session will involve three tasks for each resolution:

- 1. discussion of a proposed amendment (if any),
- 2. voting on whether to amend the resolution as proposed, and
- 3. discussion of the resolution itself **prior to online voting on all Resolutions (amended or as submitted) during the second week of October.**

Again, the actual voting on these resolutions will take place during the second week of October, by an electronic vote of DPCA voting members organized according to DA Charter Section 3.8.

Ground Rules

- 1. No new motions, amendments, or points of order will be recognized. Participants may interrupt the chair of the session in extraordinary circumstances (e.g. technical failure of communications).
- 2. The chair (or designee) will keep the queue of speakers. A participant may enter the queue by typing "**handup" in the chat box. Those unable to access the chat-box may enter the queue by requesting time to speak during periods designated by the chair for the purpose of recognizing such participants.
- 3. No participant except the chair may speak out of turn. No participant has an absolute right to speak to a particular motion.
- 4. Those speaking for the first time on a particular motion will have priority in the queue over those speaking again on that motion. Otherwise, speaking order will be determined by the chair.
- 5. Among those speaking on a topic multiple times, DPCA members will have priority over other participants.
- 6. All speakers will be limited to one minute per turn.
- 7. Voting on amendments to resolutions will be announced by the chair. Participants may vote by typing "Yes" or "No" in the chat-box, to either adopt the amendment or leave the resolution as-is, respectively. Participants unable to access the chat-box will be consulted one-by-one if the tally of the votes in chat-box is too close to call.
- 8. There is no right of any participant (whether DPCA member or not) to call for a roll-call vote, to table the resolution, or to use any other procedural tactic. The purpose of this session is to refine the resolutions and encourage thorough discussion of the substantive issues. If the resulting text of any resolution is unacceptable, the remedy is for DPCA members to vote not to adopt the resolution during the electronic vote.
