UPDATE ON TAX REFORM FOR AMERICANS ABROAD

On 22 December 2017, despite the efforts of every single organization advocating on behalf of Americans abroad, the Tax Cuts and Jobs Act became law without including any provisions aimed at easing the tax filing and foreign financial account reporting burdens borne by we who live outside the U.S.

Our campaigns did not fail. We know we moved the ball down the field. We fight on.

In the words of President Barack Obama, "Change is hard and it takes time."

So we are returning to Capitol Hill to carry on our campaign to educate lawmakers about the personal and financial hardships caused by FATCA and by inordinately complex and manifestly unjust tax code provisions uniquely harming Americans abroad. We will continue to push hard for tax reform for Americans abroad – <u>but we cannot do it without your help.</u>

Democrats Abroad will be in Washington DC March 6-8, 2018 for meetings with members of both houses of Congress from both parties. We need you to back up our efforts by calling your elected representatives demanding tax reform for Americans abroad. All you need to do that is in this Guide.

DEMOCRATS ABROAD TAX ADVOCACY

Democrats Abroad reaffirms its commitment to tax policy that – helps reduce inequality and boost opportunity raises revenue from those with the greatest ability to pay Democrats Abroad supports tax reforms that – clarify and simplify filing make the tax code fairer for all Americans do not add significantly to the federal deficit protect programs essential to national, community or individual well-being avoid creating loopholes to be exploited for tax avoidance. We fear Congress is too divided to find remedies for each of the many and myriad tax problems we have identified – or even address the flaws in the newly enacted Tax Cuts and Jobs Act of 2017.

But we need to keep trying.

We will continue to promote Residency-Based Taxation as a remedy that address the vast majority of the tax problems of Americans abroad with little effort by Congress. And we will continue to promote the elimination of FATCA filing for the accounts of Americans abroad, the elimination of the Windfall Elimination Provision and urgent fixes for the flaws in the Tax Cuts and Jobs Act.

DEMOCRATS ABROAD MARCH 2018 DOOR KNOCK

We are asking Congress to -Hold hearings on the ways the U.S. Tax Code discriminates against Americans abroad. Enact a switch from Citizenship Based Taxation to Residency Based Taxation. Fix the flaws in the Tax Cuts and Jobs Act; it imposes a new 15.5% Repatriation Tax and GILTI regime on small to medium sized businesses owned by Americans abroad. Co-sponsor HR 2136, the "Overseas Financial Access Act" – to eliminate the foreign financial accounts of Americans living abroad from reporting under FATCA. Co-sponsor HR 1205, the "Social Security Fairness Act" - to repeal the Windfall Elimination Provision that prevents Americans abroad with pensions in their countries of residence from claiming the full amount of Social Security payments owed to them. Co-sponsor HR 2710 - to establish a Commission to study the impact of Federal laws and regulations on Americans living abroad.

Our message has a better chance of generating a positive response if Congress is, at the same time, hearing from many, many Americans abroad about the urgent need for tax reform. Please participate in this Congressional CallStorm.

PRIORITY #1 CALL YOUR SENATORS AND CALL YOUR MEMBER OF THE HOUSE OF REPRESENTATIVES

Call as soon as you can and certainly NO LATER THAN WEDNESDAY MARCH 7TH. We want to walk into meetings and hear, "Yes, we've been getting a lot of calls from Americans abroad!"

Advice for finding your members of Congress and scripts for making the calls are in this Guide.

#2 You can also use the web messaging system on the website of your elected representatives to deliver your concerns, but it won't be as effective as a phone call. NOTHING IS AS EFFECTIVE AS A PHONE CALL. (Except a CallStorm of many, many thousands of phone calls!)

You can use the language for writing letters or postcards in this Guide to draft your message.

#3 Write a letter or Send a postcard.

Your written correspondence will not arrive on Capitol Hill by the time we sit down for meetings but they will help to reinforce the discussions we have next week. If you cannot call – or even if you can call - then please write!
