Dear Saba Brelvi:

Thank you for contacting the Kansas Secretary of State's office.

K.S.A. 25-1215 is the Kansas law that applies to persons who qualify for federal service voting. Any person who is eligible to register and is qualified to vote under the laws of Kansas (18 years, United States citizen, Kansas resident) and is absent shall be entitled to vote by federal service absentee ballot.

To answer each of your questions:

- 1) A U.S. citizen (and Kansas resident) who is residing abroad and intends to return to Kansas <u>is</u> allowed to vote in Kansas elections.
- 2) A U.S. citizen (and Kansas resident) who is residing abroad and is uncertain on their return, <u>is allowed</u> to vote in Kansas elections.
- 3) A U.S. citizen who has never resided in the United States (and considers Kansas as their residence when in the United States) is eligible to vote in Kansas elections.
- 4) A U.S. citizen who has never resided in the United States (and considers Kansas as their residence when in the United States) is eligible to vote in federal elections.
