- By Mail: Postmarked by May 15, 2018
- By Email or Fax: Received by May 15, 2018

Using RegisterToVoteNV.gov:

- Received by 11:59 PM, May 24, 2018

Using NVEASE.gov (which uses the FPCA):

- Received by June 5, 2018

Using FWAB or FPCA:

- Received by June 5, 2018 (regardless of delivery method)

2. What is the deadline for UOCAVA voters to Request a Ballot (already registered to vote) using an FPCA, FWAB or EASE?

Using FPCA, FWAB, or EASE:

- Request received by 5:00 PM, June 5, 2018
