Oklahoma

Yes, state laws vary greatly. However, the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) sets federal guidelines all states must follow to ensure military and overseas voters have the opportunity to vote. The Military and Overseas Voting Empowerment Act (or MOVE Act) further refined these guidelines. Section 20310 (5) defines those covered by UOCAVA as:

- (5) "overseas voter" means—
- (A) an absent uniformed services voter who, by reason of active duty or service is absent from the

United States on the date of the election involved;

(B) a person who resides outside the United States and is qualified to vote in the last place in which

the person was domiciled before leaving the United States; or

(C) a person who resides outside the United States and (but for such residence) would be qualified

to vote in the last place in which the person was domiciled before leaving the United States

The purpose of the Federal Voting Assistance Program and its website is to be a central clearinghouse for information military and overseas voters might need. Military and overseas voters do not fill out state voter registration forms and absentee ballot requests. They fill out the forms on the FVAP website, which are specifically designed for them and offer access to unique services like e-mail delivery of ballots that regular absentee voters might not be able to use in all states. You can find the answers to your questions there. For example, they list the rules for all 50 states regarding those who have never lived in the United States: https://www.fvap.gov/citizen-voter/reside The FVAP site also includes specific pages for each state which provide information about eligibility requirements.

As it pertains to state elections, Oklahoma law mirrors UOCAVA. Any voter eligible to vote in federal elections under UOCAVA is eligible to vote for any election on the ballot in their district, which would be based upon the address where they were last eligible to vote (or would have been if they were underage at the time) or if they never lived in the U.S., the address where their parent or legal guardian was last eligible to vote.

State law regarding UOCAVA voters can be found in Title 26 Section 14 of the Oklahoma State Statutes. Specifically, eligibility requirements mentioned above can be found in Section 14-137: http://www.oscn.net/applications/OCISWeb/DeliverDocument.asp?CiteID=437898
