Greetings Ms. Burch,

Thank you for contacting the Federal Voting Assistance Program.

Overseas voters can register to vote in Pennsylvania by either mail, fax, or email. If you send your registration in by mail the post marked date on the mail has to be 9 October. The reason we have postmarked by 9 October is because some states require that they receive your mail by a certain date and it doesn't matter the postmark date.

You have to ensure that you meet the deadline of 9 October for email, fax or mail. You are to send your FPCA directly to your local election official. To find out the status of your FPCA, contact your election official. Your election official will contact you if your FPCA is not accepted.

I have a question about the deadline to send in the FPCA to **register to vote** in Pennsylvania. I was a bit confused as the chart at the top of the page only provides a deadline for **mailing** in the FPCA to register to vote, but further down on the page, under "How and where to submit your FPCA," it states that the FPCA may be submitted by mail, email or fax.
