Good Afternoon,

If a U.S. citizen (formerly a Pennsylvania resident) residing abroad and intends to return, **they are eligible to vote in state elections, which would include ballot questions.**

If a U.S. citizen (formerly a Pennsylvania resident) residing abroad and return is not certain, **they are only eligible to vote for federal offices, i.e., President, U.S. Senate and Representative in Congress.**

If a U.S. citizen has never resided in the United States, are they eligible to vote in state elections-**No**

If a US citizen has never resided in the United States, are they eligible to vote in federal elections-**No**
