Dear Mr. Rydecki,

I'm a volunteer helping US citizens, living overseas, vote in US elections. We want to make sure that votefromabroad.org provides accurate and up-to-date voting information. Would you please answer the following questions.

1. If a U.S. citizen is residing abroad and they intend to return, are they allowed to vote in **state** elections? **Yes, they are eligible to vote in state elections.**
2. If a U.S. citizen is residing abroad and their return is uncertain, are they allowed to vote in **state** elections? **No, these voters would only be eligible to receive a federal-only ballot.**
3. If a U.S. citizen has never resided in the United States, are they eligible to vote in **state** elections? **No, these voters would only be eligible to receive a federal-only ballot.**
4. If a US citizen has never resided in the United States, are they eligible to vote in **federal** elections? **Yes, they are eligible to vote in federal elections.**
