Worked on further developing the **ballot return by email expansion project**

Initiated **campaigns with targeted messaging** and alerts to DA members

Ran **two large Zoom action campaigns** (co-hosted with DAUK Voter Reg)

Compiled information on the NIXIE issue

Organised **teams** country teams to check and report back **on geo-blocking** issues

Launched two big voter surveys (for the primary and general elections)

Recorded voter data and stories for analysis from surveys and Intercom cases

Organized and ran a **team of 17 volunteers** (4 Intercom responders, 1 Intercom responder/coordinator, 8 lawyers, 5 advisors), **to respond to voter protection issues** over the course of the general election, ballot curing process and the GA Senate runoff.

To date we've worked on 499 individual cases from individual voters and provided support to cc leadership, Voter Assistance and GOTV teams.


