6. PROGRESSIVE CAUCUS- OCT 12

- During the past week, we have continued to build our team; discussed collaboration with other DA caucuses, task forces, etc.; hosted our monthly meeting on October 9th (45 rsvps with approximately 30 participants), and communicated with Congressional Progressive Caucus (CPC) leadership. At our monthly meeting on October 9th, we formally began work on our Terms of Reference review, communications development, as well as our event/collaboration and issue/candidate advocacy initiatives. We also have begun work on our October newsletter and intend to submit it on October 13th or 14th for dissemination on October 15th. We have scheduled "next-steps" meetings for October 16th and the Book Club meeting for October 25th. We have tentatively scheduled our 7th Biden-Harris Progress Report for October 28th.

7. LGBTQ CAUCUS

We are also looking at a NJ-focused event featuring two LGBT candidates, one for the house the other for the Senate. We are happy to cosponsor the event with the Hispanic Caucus featuring Roberto Garcia. Our newsletter was sent out the first week in October, and features a focus on National Coming Out day, which is October 11. Other upcoming dates include November 20 which is the Transgender Day of Remembrance and December 1 which is World AIDS Day. We are brainstorming about possible events—even social media campaigns—for those dates. Our call for candidates for the Steering Committee in the last newsletter has gone unheeded, so we are actively looking for someone in AP to join. Finally, we would like to recommend an "Intercaucus Book Club" reading: Kimberlé Crenshaw has just published a collection of her most important essays, called, appropriately "On Intersectionality" We suggest at a minimum that the extended leadership of all the caucuses consider reading this together.
